

# Truist Dimension Checking Account Overview



The Truist Dimension Checking is a multi-tiered solution that rewards you with additional benefits based on your balance relationship tier. The Dimension tiers are: Tier 1 (Core) – account balances less than \$25,000; Tier 2 (Select) – account balances \$25,000 –\$99,999.99 and Tier 3 (Premier) – account balances \$100,000 or more.

	Monthly Paper Statement Fee	There is no charge for a paper statement.						
	Pays Interest	<b>Yes.</b> Interest is calculated and compounded daily on the collected balance and credited to your account monthly. Fees may reduce earnings. Interest rates are variable and can change at any time at the bank's discretion.

	Overdraft Fee Threshold	For transactions under <b>\$5</b> , Truist will waive Overdraft Fees.						
Overdraft Options	Overdraft Coverage	<p>This is an optional service you can add to your account that allows Truist, at its discretion, to authorize and pay transactions on ATM and everyday debit card purchases when there are insufficient funds in your account.</p> <p><b>Opt out:</b> Your account is automatically opted out of Overdraft Coverage at account opening. By opting out of Overdraft Coverage, Truist will automatically decline all future ATM and everyday debit card transactions that would overdraw your account. Since these transactions will be declined when you have insufficient funds, you will not be charged the Overdraft Fee for ATM or one-time debit card transactions.</p> <p><b>Opt in:</b> By opting in to Overdraft Coverage, Truist may pay ATM and everyday debit card transactions at the bank's discretion when your account does not have sufficient funds to cover the transaction.</p> <p>Your choice to opt in or opt out of Overdraft Coverage does not apply to checks, ACH and recurring debit card transactions. Truist may pay these transactions at our discretion and fees may apply.</p>						
	Overdraft Protection	<p>This optional service helps you avoid overdraft fees and/or declined transactions by linking your Truist checking or money market account (the "protected" account) to another Truist deposit account, credit card<sup>5</sup> or line of credit<sup>5,6</sup> (the "protector" account). We will use available funds in your linked account (the "protector" account), to authorize or pay your transactions if there are insufficient funds in your checking or money market account. The amount transferred is the exact amount of the overdraft, based on balance availability. There is no fee for the Overdraft Protection transfer.</p> <p>If your account has both Overdraft Protection and Overdraft Coverage, Truist will use Overdraft Protection first. If your account has neither, everyday debit card and ATM transactions that exceed the account balance will be declined.</p>						

<b>Other Account-Related Fees</b>	ATM Fees	<p><b>No fee for transactions (cash withdrawal, balance inquiries or transfers) at Truist ATMs<sup>7</sup></b></p> <p><b>Non-Truist ATMs fees are based on the following tiers:</b></p> <ul style="list-style-type: none"> <li>• Tier 1 (Core) – One non-Truist ATM fee waiver and one surcharge rebate<sup>8</sup> per statement cycle.</li> <li>• Tier 2 (Select) – Three non-Truist ATM fee waivers and three surcharge rebates<sup>8</sup> per statement cycle.</li> <li>• Tier 3 (Premier) – Unlimited non-Truist ATM fee waivers and surcharge rebates<sup>8</sup> per statement cycle.</li> <li>• 3% International POS &amp; 3% ATM and international assessment per transaction for all tiers.</li> <li>• \$5 per transaction at non-Truist ATMs outside the U.S.</li> </ul>

<b>Deposit and Withdrawal Processing Policies</b>	Funds Availability	<p><b>Funds are generally available the next business day after the deposit is received.</b></p> <ul style="list-style-type: none"> <li>• Transactions are processed each business day (Monday through Friday except federal holidays) during nightly processing and the results are posted to your account.</li> <li>• Check deposits will be posted to your account and available for use after nightly processing unless a hold is placed.</li> </ul> <p><i>See the Funds Availability Policy in the Bank Services Agreement for account details.</i></p>
	Posting Order	<p>Truist will post items to your account based on your available balance. The available balance can be impacted by pending transactions. Examples of common pending transactions can be found in the Bank Services Agreement.</p> <p>Once the available balance is determined, prior-day credits and debits will post before current-day credits and debits. Once prior-day credits and debits are determined, if any, transactions will post in order according to the groupings below:</p> <p><b>Deposits and credits</b> – All deposits and credits will be posted to the account first. This includes cash, checks deposits and incoming transfers (i.e., direct deposits and wires) received before the cutoff time at the location the deposit or transfer was made.</p> <p><b>Bank-initiated transactions</b> – These transactions include corrections and Deposited Item Returned Checks.</p> <p><b>Client-initiated withdrawals and debits</b> – Withdrawals/payments that have been previously authorized and cannot be returned unpaid. This category includes: debit card purchases, ATM withdrawals, account transfers and teller-cashed checks. If more than one of these transactions is received for payment from your account, the items are generally sorted and paid based on the date and time of the transaction. For a debit card transaction, if a merchant does not seek authorization from the bank at the time of the transaction, the date the transaction is received for payment from your account will be used.</p> <p><b>Client-initiated withdrawals and debits such as ACH (automated payments)</b> – Transactions such as bills that are paid by authorizing a third party to withdraw funds directly from your account. If there is more than one of these types of transactions, they will be sorted by the date and time that they are received. Multiple transactions that have the same time will be sorted and paid from lowest to highest serial number.</p> <p><b>Client-initiated checks</b> – Checks will be posted and sorted in sequential order.</p> <p><b>Bank fees</b> – Fees, such as the Monthly Maintenance Fee, will post to your account last. Please note that some fees will be posted to your account at the time they are incurred and others, like maintenance fees, will post last.</p>

<sup>1</sup> Direct Deposit: A qualifying direct deposit is an electronic credit via ACH deposited to your account during the current statement cycle. Pre-authorized transfers made from one account to another or deposits made via a branch, ATM, online transfer, mobile device, debit card/prepaid card number or the mail are not eligible to meet this requirement.

<sup>2</sup> Total Combined Balance: The sum of all balances within the Truist personal deposit accounts (checking, savings, money market or CDs), IRAs or brokerage accounts introduced through Truist Investment Services, Inc.

<sup>3</sup> Related Truist Personal Credit Card, Mortgage or Consumer Loan: The following accounts will qualify to waive the monthly maintenance fee - a Truist personal credit card, personal mortgage or a consumer loan (including LightStream<sup>SM</sup>).

<sup>4</sup> Linked Small Business Checking Account: Eligible Small Business account types to be linked include: Truist Dynamic Checking, Business Interest Checking, Simple Business Checking and Business Value 200.

<sup>5</sup> Credit card and/or line of credit are subject to credit approval.

<sup>6</sup> Truist Home Equity Lines cannot be linked for Overdraft Protection in Texas.

<sup>7</sup> For accounts opened in Texas, customers will receive two non-Truist ATM fee waivers per statement cycle and two ATM surcharge rebates not to exceed \$3.00 per rebate.

<sup>8</sup> Surcharge rebates: This amount is not to exceed \$3.00 per rebate.

<sup>9</sup> This fee will be charged when a Check or other items are returned to a depositor because it could not be processed by the originating bank.
