Use

The *Addendum A to Note – 90 Day Average SOFR in Advance* (Form 630544C) is used when the 90 Day Average SOFR in Advance Rate with 2 Look Back Days is selected as the applicable index for a variable rate commercial note.

This Addendum provides that the interest rate shall be based on the 90 Day Average SOFR in Advance rate in effect two (2) business days prior to the commencement of the interest period.

The Addendum must be referenced in and attached to the applicable commercial note.
