Use

The *First Preferred Ship Mortgage* (Form 630156) is used to record a security interest in a vessel registered with the U.S. Coast Guard.

<u>Note</u>: Under the Maritime Act, a mortgage may secure only a **single obligation** and **not all indebtedness** of the named Borrower.

Vessel registration

Commercial

All vessels of five (5) net tons or more used for **commercial** purposes **must** be registered with the U.S. Coast Guard.

Pleasure

A vessel of five (5) net tons or more (generally most vessels more than 25 feet in length will meet this requirement) used for **pleasure may** be registered with the U.S. Coast Guard. SunTrust policy requires registration and recordation of a ship's mortgage on these vessels. A recorded ship's mortgage will always have priority over a lien filed against the title, including prior liens.

Where to file

Local Filing is no longer required. The mortgage is recorded in the Central Filing Office only **at the following address**:

Distribution

One (1) original and one (1) copy of the form should be sent to the Coast Guard at the above address. The original will be retained by the Coast Guard and the copy, with recordation information, will be returned to the mortgagee. The original of each form should be clearly labeled "original".

Fees

Fee for filing is \$20.00 (\$4.00 per page; front and back are considered two (2) pages). Fee must be paid by check payable to "USCG". The fee covers the original and one (1) copy.
